- 2. This placement runs on a 24 hour, 7 day a week rotation. M-F schedule available at an increased cost of +15%.
- 3. Spots run through all stations listed, no stations may be dropped or substituted.
- 4. Prelogs are not available. Post logs provided at the end of the run.
- 5. Spots run over a 30-Day period.
- 6. All rates include a FREE Infrastructure Review.
- 7. All stations subject to availability at time of placement.
- 8. All placements after November 15, subject to potential rate increase of +25%.
- 9. :60 Second Spots are double the :30 second price quoted in this rate card.
- 10. Affiliate list subject to change.
- 11. "t" denotes translator station.
- 12. NMS will produce for Client a <u>FREE</u> 30-sec or 60-sec radio spot. Client must provide a general script or bullet points with information they would like to use in the radio spot and approve a final script in writing sent to Client by NMS for approval. NMS will use the best possible radio voice and/or music available at the time of production. Turnaround time for radio production is 3-7 days from receipt of an approved script from Client.
